These requirements must be fulfilled every three years unless expected under Rule of Court 9.31 and Business & Professionals Code Section 6070. Myron Moskowitz's seminars have received approval from the State Bar of California.

Landlord-Tenant Law – Myron Moskowitz is the author of several publications regarding landlord-tenant law. In this seminar, he draws on his previous advocacy for low-income tenants and experience as a witness in landlord-tenant disputes to engage MCLE students. New cases, changing statutes, wrongful eviction lawsuits, tort liability and other issues will be explored. (Approved for 3 CLE credits)

Myron Moskowitz's "How to Win Appeals and Writs" and "Landlord-Tenant Law" have previously been taught in events sponsored by The American Bar Association, American Association of Law Schools, California Judges Association, San Francisco Bar Association, and various other California law associations.

These seminars will be held at several venues throughout the California Bay Area, including Golden Gate University and the Alameda County Bar Association.
